IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-NINE

AN ACT Providing Additional Driver License Examiners in the Division of Motor Vehicles.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, applicants for driver license examinations have had to wait long periods of time for the examinations due to the heavy workload and limited number of employees to carry out the examinations; and

Whereas, if the waiting period is to be reduced to the point where it can be considered reasonable and realistic, it is imperative that the field force in the Divison of Motor Vehicles be increased; and

Whereas, the following legislation is vitally necessary to realize the benefits during the coming summer months when the workload is heaviest; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Allocation. The following funds shall be allocated from the General Highway Fund Surplus to carry out the purposes of this Act.

STATEMENT OF FACT

This bill appropriates funds to the Division of Motor Vehicles to enable it to hire more driver license examiners to carry out driver licensing duties. The need for the appropriation is set forth in the emergency preamble.
