Amend the Bill in Part A under the caption "EDUCATIONAL
AND CULTURAL SERVICES, DEPARTMENT OF" by inserting
at the end before the total for the department
the following: 'Education - Teachers' Retirement

Further amend the Bill in Part A under the caption
"TOTAL DEPARTMENT OF EDUCATIONAL AND CULTURAL SERVICES" to
reflect the purposes of this amendment.

Further amend the Bill in Part A under the caption
"FINANCE AND ADMINISTRATION, DEPARTMENT OF" by inserting
before the total the following:

'Retirement and Employee Benefit Study

All Other 150,000 ---

To provide funds for a study of the retirement system and other employee benefits to be administered by the Department of Finance and Administration.'

Further amend the Bill in Part A under the caption "TOTAL DEPARTMENT OF FINANCE AND ADMINISTRATION" to reflect the purposes of this amendment.

Further amend the Bill in Part A under the caption "HUMAN SERVICES, DEPARTMENT OF" by inserting after the caption the following:

'Aid to Families with Dependent Children

All Other 1,260,000 1,260,000

Medical Care

All Other 420,000 420,000'

Further amend the Bill in Part A under the caption "TOTAL DEPARTMENT OF HUMAN SERVICES" to reflect the purposes of this amendment.

Further amend the Bill in Part A to have the total of Part A to reflect the purposes of this amendment.

Further amend the Bill by inserting before the emergency clause the following:

'PART F

Allocation of fund. In order to provide the necessary expenses for operation and administration of the Bureau of Alcoholic Beverages and the State Liquor Commission, the following amounts, or as much as may be necessary, are allocated from the revenues derived from operations of the fund:
