HOUSE AMENDMENT "A" to H.P. 1564, L.D. 1686 , Bill,  
"AN ACT to Make Corrections and Clarify Provisions of the  
Inland Fisheries and Wildlife Laws."

Amend the Bill by inserting after section 4 the following:

'Sec. 5. 12 MRSA §7076, sub-§6, first sentence, as  
enacted by PL 1979, c.420, §1, is amended to read:  
A combination fishing and hunting license shall be issued  
upon payment of ~~§3~~ §5, plus the issuing fee, to a Maine resident  
in the Armed Forces of the United States who is stationed outside  
the State of Maine.

Sec. 6. 12 MRSA §7076, sub-§10, ¶A, as enacted by PL 1979,  
c. 420 , §1, is amended to read:

A. The fee for this license shall be ~~§38~~ §40 for those  
camps with an enrollment of less than 50 campers, ~~§63~~ §65 for  
those camps with an enrollment of not less than 50 campers  
but not more than 75 campers, and ~~§94~~ §96 for those camps  
with an enrollment of more than 75 campers.

Sec. 7. 12 MRSA §7101, sub-§5, as enacted by PL 1979,  
c.420, §1, is amended to read:

5. Schedule of fees.

A. Resident junior hunting license.....\$1.50  
(10 years of age or older and under 16)

- B. Resident hunting license.....~~\$--7-50~~ \$9.50  
(16 years of age or older)
- C. Resident combination hunting and fishing  
license.....~~\$-12-50~~ \$16.50
- D. Resident combination archery hunting  
and fishing license.....~~\$-12-50~~ \$16.50
- E. Nonresident junior hunting license.....\$ 15.50  
(10 years of age or older and under 16)  
(Permits hunting of all species, except  
deer and bear with firearms)
- F. Nonresident small game hunting license.....~~\$-30-50~~ \$35.50  
(Permits hunting of all species, except  
deer and bear)
- G. Nonresident big game hunting license.....~~\$-60-50~~ \$65.50  
(Permits hunting of all species, including  
deer and bear)
- H. Alien big game hunting license.....~~\$100-00~~ \$105.00  
(Permits hunting of all species, including deer and bear)

Further amend the Bill in section 6 in that part designated "\$7102." by striking out all of subsections 2 and 3 and inserting in their place the following:

2. Issuance. The commissioner, through his agents, shall issue an archery license to eligible persons. The issuing agent shall retain a fee of 50¢ for each license issued.

3. Schedule of fees.

- A. Resident archery license.....~~\$9.50~~
- B. Resident combination archery hunting and fishing  
license (available from the department in Augusta  
only).....\$16.50
- C. Nonresident archery license.....\$35.50

Further amend the Bill by inserting after section 6 the following:

'Sec. 7. 12 MRSA §7103, sub-§3, as enacted by PL 1979, c. 420, §1, is amended to read:

3. Fee. The fee for a falconry license shall be ~~§13~~ §15.

Sec. 8. 12 MRSA §7106, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a pheasant hunting permit shall be ~~§3.25~~ §5.25 25¢ of which shall be retained by the agent.

Sec. 9. 12 MRSA §7131, sub-§1, as enacted by PL 1979, c. 420, §1, is amended to read:

1. Schedule of fees.

A. Resident trapping.....~~§13~~ §15

B. Nonresident trapping.....~~§250~~ §255'

Further amend the Bill by inserting after section 8 the following:

' Sec. 9. 12 MRSA §7151, sub-§5, as enacted by PL 1979, c. 420, §1, is amended to read:

5. Schedule of fees.

A. Resident fishing.....~~§7.50~~ §9.50  
(16 years of age or older)

B. Resident combination hunting and fishing.....~~§12.50~~ §16.50

C. Resident combination archery hunting and fishing.....~~§12.50~~ §16.50

- D. Junior nonresident fishing.....\$ 4.00  
(12 years of age or older and under 16)
- E. Resident or nonresident 3-day fishing.....~~\$-7.50~~\$9.50  
(Valid for 3 days from date indicated on license)
- F. Nonresident 7-day fishing.....~~\$12.50~~\$17.50  
(Valid for 7 days from date indicated on license)
- G. Nonresident 15-day fishing.....~~\$15.50~~\$20.50  
(Valid for 15 days from date indicated on license)
- H. Nonresident season fishing.....~~\$25.50~~\$30.50  
(16 years of age or older)

Sec. 10. 12 MRSA §7153, sub-§2, as enacted by PL 1979,

c. 420 , §1, is amended to read:

2. Fee. The minimum fee for these permits shall be ~~§32~~ §24.

Further amend the Bill in section 9 by striking out all of subsection 3 and inserting in its place the following:

'3. Fee. The fee for a tournament permit shall be:

A. For a tournament with 20 or less participants, who are all members of the sponsoring club.....\$ 7

B. For all other tournaments.....\$27'

Further amend the Bill by inserting after section 9 the following:

'Sec. 10. 12 MRSA §7171, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a live bait dealer's license shall be ~~§13~~ §15 for each calendar year.'

Further amend the Bill by inserting after section 10 the following:

'Sec. 11. 12 MRSA §7172, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a live smelt bait dealer's license shall be ~~§60~~ §62 for each calendar year.

Sec. 12. 12 MRSA §7201, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a license to sell commercially grown or imported fish shall be ~~§15~~ §17.

Sec. 13. 12 MRSA §7205, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for such a license shall be ~~§10~~ §12.

Sec. 14. 12 MRSA §7231, sub-§3, as enacted by PL 1979, c. 420, §1, is amended to read:

3. Fee. The fee for a roadside menagerie permit is ~~§63~~ §65.'

Further amend the Bill in section 11 in that part designated "§7235." by striking out all of subsection 2 and inserting in its place the following:

'2. Fee. The annual fee for a breeder's license is \$15.'

Further amend the Bill in section 13 in that part designated "§7301." by inserting after subsection 6 the following:

'7. Fee. The annual fee for a resident guide license is \$34. The annual fee for a nonresident guide license is \$130. The annual fee for an alien guide license is \$15.'

Further amend the Bill in section 13 in that part designated "§7301." in subsection 7-A by striking out all of the first sentence and inserting in its place the following:

'A guide whose license is not suspended or revoked may renew that license annually upon the payment of the annual fee.'

Further amend the Bill by inserting after section 14 the following:

'Sec. 15. 12 MRSA §7331, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a special dog training area license is \$15 \$17.

Sec. 16. 12 MRSA §7332, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. The fee for a license to hold field trials for sporting dogs is \$15 \$17.

Sec. 17. 12 MRSA §7332, sub-§3, ¶C, sub-¶(2), as enacted by PL 1979, c. 420, §1, is amended to read:

(2) Licensees shall pay the department for services of its representative at the field trials at a rate of \$15 \$17, or the actual costs to the department, whichever is higher, per day.

Sec. 18. 12 MRSA §7351, sub-§2, as enacted by PL 1979, c. 420, §1, is amended to read:

2. Fee. Residents shall pay an annual fee of \$7 \$9 and alien residents shall pay an annual fee of \$32 \$35 for a taxidermist license.'

Further amend the Bill in section 15 in that part designated "§7352." by striking out all of subsection 2 and inserting in its place the following:

'2. Fee. The annual fee for a hide dealer's license shall be \$34 for residents of this State and \$68 for nonresidents.'

Further amend the Bill in section 23 in subsection 15, ¶E by striking out all of the last <sup>sentence</sup> / and inserting in its place the following:

'The bear transportation tag shall cost \$5, 50¢ to be retained by the issuing agent;'

Further amend the Bill in section 23 in subsection 15, ¶F by striking out all of the last sentence and inserting in its place the following:

'The bear transportation tag shall cost \$55.50/<sup>50¢</sup> to be retained by the issuing agency, except that no fee shall be required of any resident of this State who is serving in the Armed Forces of the United States; and'



Further amend the Bill by inserting after section 27 the following:

'Sec. 28. 12 MRSA §7458, sub-§15, ¶D, last sentence, as enacted by PL 1979, c. 420, §1, is amended to read:  
The deer transportation tag shall cost ~~§3~~ §5; 50¢ to be retained by the issuing agent.

Sec. 29. 12 MRSA §7458, sub-§15, ¶E, last sentence, as enacted by PL 1979, c. 420, §1, is amended to read:  
The deer transportation tag shall cost ~~§53-50~~ §55.50; 50¢ to be retained by the issuing agent, except that no fee shall be required of any resident of this State who is serving in the Armed Forces of the United States.'

Further amend the bill by renumbering the sections to read consecutively.

Fiscal Note

This legislation incorporates the fee increases to the Department of Inland Fisheries and Wildlife as proposed in L.D. 1671, as amended by House Amendment. The fiscal note on that bill is applicable to this amendment as well.

Statement of Fact

This amendment incorporates the fee changes of L.D. 1671 into the revision bill. This will provide continuation of the

fee changes after January 1, 1980, when the revision bill takes effect.
