'Amounting to ~~95,000,943~~ 86,039,543 for the fiscal year ending June 30, 1980, and ~~95,786,287~~ 89,634,207 for the fiscal year ending June 30, 1981.

Sec. 11. Unallocated study. The Legislature finds that revenues to the dedicated Highway Fund have substantially declined because of reduced gasoline consumption caused by the spiraling cost of gasoline and the successful conservation efforts undertaken by Maine citizens. It finds that costs for the Department of Transportation have increased at an accelerated pace due to inflation. It finds that the gap between revenues and expenditures will be significant for the next biennium unless positive actions are taken.

It is essential that long-range plans be made for the department to identify those high priority programs and services which are essential for the preservation of public safety.

Therefore, the Commissioner of Finance and Administration is directed to employ objective professional consultants at the expense of the Highway Fund to evaluate the administration, planning and operation of the programs and services funded by the highway budget. The evaluation should include a study of the cost-effectiveness of programs, alternative methods of delivery and priority of services. The consultants shall coordinate their activities with the Joint Standing Committee on Audit and Program Review.

The study should make recommendations as to the source and size of future revenues which would be required to maintain the

basic priority and other essential services of the department. It will also provide information necessary to balance Highway Fund activities properly against projected needs for the next biennium.

This study shall be completed and a report, including all necessary legislation, made to the Governor in a timely manner prior to a special session of the Legislature to be held no later than September 15, 1980, to deal with its recommendations.

Statement of Fact

The purpose of this amendment is to compensate for the expected shortfall of \$16,700,000 in revenues to the Highway Fund. This amendment increases operator license fees and driver examination fees, increases certificate of title fees and reduces program allocations.

Fee Increases

This amendment increases operator license fees by \$1.50 per year for increase revenues of \$1,050,000. In addition, driver examination fees are increased by \$5 for the initial fee and by \$3 for subsequent fees to produce increased revenues of \$360,000. Certificate of title fees are increased \$2 to produce added revenues of \$500,000. Total increases produce added revenues of \$1,631,000.
