COMMITTEE AMENDMENT "B" to H.P. 1757, L.D. 1887, Bill,
"AN ACT to Authorize Bond Issue in the Amount of \$6,000,000
for Improvements to Vocational-technical Institutes."

Amend the Bill by striking out all of the Title and
inserting in its place the following:

'AN ACT to Authorize Bond Issue in the Amount of \$8,000,000
for Improvements to Vocational-technical Institutes and the
Maine Maritime Academy.'

Further amend the Bill by striking out all of the
2nd paragraph of the emergency preamble and inserting
in its place the following:

'Whereas, vocational-technical institutes throughout
the State and the Maine Maritime Academy are in immediate need
of capital construction and improvements; and'

Further amend the Bill in section 1 by striking out in the
first sentence the figure "\$6,000,000" and inserting
in place thereof the figure '\$8,000,000'

Further amend the Bill in section 1 by striking out
all of the 2nd sentence and inserting in its place the
following:

'Any bonds issued pursuant to this authorization shall be issued
prior to July 1, 1985.'

Further amend the Bill in section 3 by striking out
all of the last sentence and inserting in its place the

following:

'Any unencumbered balances remaining at the completion of the projects in section 6 shall lapse to the debt service account established for the retirement of these bonds.'

Further amend the Bill by striking out all but the last paragraph of section 6 and inserting in its place the following:

'Sec. 6. Allocations from General Fund bond issue.

Further amend the Bill by striking out in the first sentence of the statutory referendum procedure the word and figures "June 11, 1980" and inserting in their place the word and figures 'June 10, 1980'

Further amend the Bill by striking out all of the 3rd paragraph from the end before the emergency clause and inserting in its place the following:

'Shall a bond issue be ratified in the amount of \$8,000,000 for improvements to vocational-technical institutes and the Maine Maritime Academy.'

Statement of Fact

The purpose of this amendment is to correct the year of allocation and the date for the elections and to add the Eastern Maine Vocational-technical Institute and the Maine Maritime Academy to the projects to be done.
