SENATE AMENDMENT "A" to HOUSE AMENDMENT "A" to H.P. 291, L.D. 335, Bill, "AN ACT Changing the Name of the Department of Manpower Affairs and Clarifying the Term of its Commissioner."

Amend the Amendment by striking out all of the 5th paragraph after the title and inserting in its place the following:

'Further amend the Bill by striking out all of section 5 and inserting in its place the following:

'Sec. 5. 26 MRSA §41, first and 2nd sentences, as repealed and replaced by PL 1977, c. 674, §23, are amended to read:

A Bureau of Labor <u>Standards</u> within the Department of <u>Man-power-Affairs</u> <u>Labor</u>, as heretofore established and hereinafter in this Title called the "bureau," shall be maintained under the direction of an officer whose title shall be Director of the Bureau of Labor and state factory inspector, hereinafter in this Title, except in chapter 13, called the "director." He shall be appointed by the Commissioner of <u>Manpower-Affairs</u> <u>Labor</u> and shall hold office at the pleasure of the commissioner.'

Further amend the Amendment by inserting after the 5th paragraph the following:

'Further amend the Bill by inserting after section 5 the following:

'Sec. 6. 26 MRSA §48, as amended by PL 1975, c. 59, §2, is further amended to read:

§48. Reports

All reports to the Bureau of Labor <u>Standards</u> involving deaths, injuries and occupational diseases shall be available to the injured employee, his survivors or representatives upon written request and upon payment of reasonable cost for the copies.

Sec. 7. 26 MRSA §81, sub-§2-A, as amended by PL 1975, c. 59, §3, is further amended to read:

2-A. Bureau. "Bureau" shall mean the Bureau of Labor Standards within the Department of Manpower-Affairs Labor.'

Further amend the Amendment by inserting at the end before the Statement of Fact the following:

'Further amend the Bill by inserting at the end before the Statement of Fact the following.

'Sec. 24. Name of Bureau. Whenever in the Revised
Statutes the words Bureau of Labor appear, they mean and are
amended to read Bureau of Labor Standards.

Further amend the Bill by renumbering the sections to read consecutively.'

Statement of Fact

This amendment changes the name of the Bureau of Labor to the Bureau of Labor Standards, to avoid confusion with the new Defartment of Labor.
