Amend the Bill by striking out everything after the enacting clause and before the emergency clause and inserting in its place the following:

'Sec. 1. 29 MRSA §532, 4th ¶, as amended by PL 1979, c. 738, §2, is further amended to read:

The fee for a motorcycle or motor driven cycle learner's permit shall be \$10 through February-207-1901 June 30, 1981 and \$5 thereafter, which shall include the first road test. The fee for all subsequent examinations shall be \$5 through February-207 1901 June 30, 1981 and \$3 thereafter.

Sec. 2. 29 MRSA §542, first ¶, last sentence, as amended by PL 1979, c. 738, §3, is further amended to read: The fee for such license shall be \$.6 through February-287-1981 June 30, 1981 and \$10 thereafter.

1. Class 1 or 2 license. The examination fee shall be \$13 through February-287-1981 June 30, 1981 and \$8 thereafter, which shall include the first road test. All subsequent examination fees shall be \$8 through February-287-1981 June 30, 1981 and \$5 thereafter.

2. Class 3 license. The examination fee shall be \$10 through February-207-1901 June 30, 1981 and \$5 thereafter, which shall include the first road test. All subsequent examination fees shall be \$5 through February-207-1901 June 30, 1981 and \$3 thereafter.

Statement of Fact

The purpose of this amendment is to remove the sunset provisions from the driver examination, driver license and motor vehicle title fees' increase and replace with a new sunset provision, June 30, 1981.

It is estimated that this will generate additional revenue in the amount of \$682,297 for the fiscal year ending June 30, 1981.
