STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED AND EIGHTY-ONE

AN ACT to Abolish the Office of Energy Resources.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 2 MRSA § 6, sub-§ 6, as last amended by PL 1979, c. 651, § 2, is further amended to read:

6. Range 85. The salaries of the following state officials and employees shall be within salary range 85:

Director of Veterans Services;

Director of Civil Emergency Preparedness;

Examiner and Chief Accountant of the Public Utilities Commission;

~~Director of the Office of Energy Resources;~~

Executive Director, Historic Preservation Commission;

Members, Maine Employment Security Commission.

Sec. 2. 3 MRSA § 507, sub-§ 6, ¶ B, sub-¶ (5), as enacted by PL 1979, c. 654, § 3, is repealed as follows:

~~(5) Office of Energy Resources;~~

Sec. 3. 5 MRSA Pt. 13, as amended, is repealed.

Sec. 4. 10 MRSA § 1413, sub-§ 7, as enacted by PL 1979, c. 503, § 2, is repealed and the following enacted in its place:

7. Director. “Director” means the Director of the Division of Community Services.

Sec. 5. 10 MRSA § 1413, sub-§ 11, as enacted by PL 1979, c. 503, § 2, is repealed and the following enacted in its place:

11. Manual of Accepted Practices. “Manual of Accepted Practices” means the Manual of Accepted Practices prepared by the Division of Community Services in conformance with the State of Maine Energy Conservation Building Standards.

Sec. 6. 10 MRSA § 1419, first sentence, as enacted by PL 1979, c. 503, § 2, is amended to read:

All revenue generated from fees collected by the ~~Office of Energy Resources~~ **Division of Community Services** under this chapter shall be deposited with the treasurer in a separate fund to be expended for the administration of this chapter.

Sec. 7. 10 MRSA § 9102, sub-§ 2, ¶ J, as amended by PL 1979, c. 606, § 4, is repealed.

STATEMENT OF FACT

This bill abolishes the Office of Energy Resources.
