	Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after ad- journment unless enacted as emergencies; and	
	Whereas, Piscataquis County has certain expenses and liabilities which must be met as they become due; and	
	Whereas, it is necessary that the taxes for the year 1982 hereinafter mentioned be immediately assessed in order to provide the required revenue for the county; and	
	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Consti- tution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it	

1 Sec. 1. Piscataquis County; taxes apportioned. 2 Resolved: That the following sum is hereby granted as a tax 3 on Piscataquis County to be apportioned, assessed, collected 4 and applied to the purposes of paying debts and necessary 5 expenses of the county as authorized herein, and for other 6 purposes of law, for the calendar year 1982:
