1 SENATE AMENDMENT "A" to H.P. 2300, L.D. 2133

- 2 1. To separate out specific costs of salaries, wages 3 and fringe benefits from each "Personal Services" line item 4 for each account in the county budget. This process does 5 not change any of the totals for Personal Services in the 6 bill:
- 7 2. To raise the appropriation for "Commodities" under 8 the budget for the Registry of Probate by \$2,000. This 9 increase provides funds for microfilming probate records; 10 and
- 3. To specify that fringe benefit funds shall only be used for that purpose and that any unused funds in fringe benefit accounts shall be carried forward to the next fiscal year.
