17 18 19 20 21	AN ACT to Provide that an Absentee Ballot for a Municipal Election May be Requested on the Application Requesting an Absentee Ballot for a State Election.
22 23	Be it enacted by the People of the State of Maine as follows:
24 25	Sec. 1. 21 MRSA §1252, sub-§2, as amended by PL 1981, c. 436, §3, is further amended to read:
26 27 28 29 30 31 32 33 34	2. <u>Content of application</u> . The application must contain a place for the following: Name of applicant, address, address to which ballot is to be sent, title and year of election at which ballot is to be cast, name of party in which he is or desires to be enrolled, date of application and signature of appli- cant. It must contain a place for the applicant to designate the reason for requesting an absentee bal- lot, the name of a person to whom his ballot may be

1 delivered and a place for the registrar to certify the applicant is registered and the party in 2 whether 3 which he is or desires to be enrolled. It shall con-4 tain a place for the applicant to request an absentee 5 ballot for the municipal election, if a municipal 6 election is to be held on the same date as the state-7 wide election. It shall contain a conspicuously-8 summary warning of the provisions of Title printed 9 17-A, section 703.

10 11 Sec. 2. 21 MRSA §1253, sub-§2, as amended by PL 1977, c. 696, §177, is further amended to read:

12 Application or request received. On receipt 2. 13 of a completed application or a request for an absen-14 tee ballot signed by the applicant, the clerk shall 15 deliver an absentee ballot and return envesend or 16 lope forthwith to the applicant or to a 3rd person 17 designated in the application or request. If a 18 municipal election is to be held on the same date as a statewide election, absentee ballots for the munic-19 20 ipal and statewide election may be requested on the 21 same application. The clerk shall issue to any 3rd 22 person so designated only enough absentee ballots to 23 insure that such a person shall not be in possession 24 any time of more than 40 absentee ballots for at 25 voters in a municipality. Such a 3rd person shall, 26 unless good cause is shown, return an absentee ballot 27 to the clerk's office within the time limits provided The clerk shall include a ballot 28 in section 1255. 29 application to be completed by the person who signed 30 only a written request, unless the written request is sufficient as provided in subsection 1-A. 31 The clerk shall type or write in ink the name and the legal ad-32 dress of the person for whom the absentee ballot 33 is 34 intended in the upper left hand section of all return 35 envelopes.

36 If the clerk receives a duplicate application from a 37 person from whom the clerk has received a return 38 envelope apparently containing an absentee ballot, 39 the clerk shall not furnish another absentee ballot 40 for such person.

41 The clerk may issue a 2nd absentee ballot to an 42 applicant if the applicant in person or in writing 43 requests one and: 1 A. If such applicant states good cause, includ-2 ing, but not limited to, loss of, spoiling of or 3 damage to the first absentee ballot; or

4 If an absentee ballot for such applicant в. 5 which was furnished to a designated 3rd person is 6 not returned to the clerk's office within 5 business days of the date such ballot was sent or 7 8 delivered to such 3rd person or by 10 a.m. on the day before election day, whichever is earlier. 9 This paragraph shall not be construed to 10 affect 11 the time for delivery of absentee ballots under 12 section 1255.

## STATEMENT OF FACT

14 The purpose of this bill is to permit a voter to 15 request an absentee ballot for a municipal election 16 on the same application used to request an absentee 17 ballot for a statewide election.
