17 AN ACT Concerning Signs on the Maine
18 Turnpike.

20 Be it enacted by the People of the State of Maine as
21 follows:

22 Sec. 1. 23 MRSA §1201, sub-§7, as repealed and
23 replaced by PL 1975, c. 30, is repealed and the fol-
24 lowing enacted in its place:

25 7. Falmouth-Coastal Route 1; Interstate 95.
26 Such signs shall be constructed and maintained on the
27 Maine Turnpike at points southerly no more than 2
28 miles, one mile and at exit 9 and shall be worded as
29 follows:

8 Sec. 2. 23 MRSA §1201, sub-§35 is enacted to
9 read:

10 35. Interstate 95; Interstate 295; no tolls.
11 Such sign shall be constructed and maintained on the
12 Maine Turnpike no more than one mile south from the
13 South Portland interchange and shall be worded as
14 follows:

15 Interstate 295 - Exits 6A or 7
16 Interstate 295 to Interstate 95 - Exits 6A or 7
17 Interstate 95 - Exit 9
18 No Tolls

19 STATEMENT OF FACT

20 The purpose of this bill is to inform
21 north-bound motorists that certain roads, notably
22 Interstates 295 and 95, provide similar transporta-
23 tion services to the Maine Turnpike but at no charge.
