6 COMMITTEE AMENDMENT "A" to H.P. 129,
7 L.D. 137, Bill, "AN ACT Amending the Charter of the
8 Aroostook Prestile Treatment District and the Charter
9 of the Presque Isle Sewer District to Authorize the
10 Withdrawal of Municipalities from the Aroostook
11 Prestile Treatment District."

12 Amend the Bill in section 1 by striking out all
13 of the last 6 lines (page 2, lines 18 to 23 in L.D.)
14 and inserting in their place the following: '~~of pre-~~
15 ~~viding collecting and treating sewage in said dis-~~
16 ~~trict a system of public sewerage and drainage for~~
17 ~~the comfort, convenience and health of the inhabi-~~
18 ~~tants of said district, with all the rights, privi-~~
19 ~~leges and immunities incident to similar corpora-~~
20 ~~tions.'~~

21 Further amend the Bill in section 4 in the 4th
22 line from the end (page 3, line 1 in L.D.) by strik-
23 ing out the underlined words "resign immediately
24 after" and inserting in their place the following:
25 'cease to serve as trustees once'

26 Further amend the Bill in section 6 in section 23
27 by striking out all of the first underlined sentence
28 (page 3, lines 15 to 20 in L.D.) and inserting in its
29 place the following: 'The city council of Presque
30 Isle, the city council of Caribou, or the selectmen
31 of Easton may, on behalf of the people and territory
32 from which they are elected, upon 90 days written
33 notice to the district, request in writing to with-
34 draw from the district.'

35 Further amend the Bill in section 6 in section 23
36 in the first paragraph, next to the last line (page
37 3, line 25 in L.D.) by inserting after the underlined
38 word "those" the underlined word 'trustees'

1 Further amend the Bill in section 6 in section 23
2 in the 2nd paragraph, 9th line (page 3, line 35 in
3 L.D.) by striking out the underlined word
4 "quasi-municiple" and inserting in its place the
5 underlined word 'quasi-municipal'

6 Further amend the Bill in section 6 in section 23
7 in the 2nd paragraph, 14th line, (page 3, line 40 in
8 L.D.) by striking out the underlined word "directly"
