**AN ACT Appropriating \$5,000 for the Pink Panthers of Millinocket to Represent Maine in the Cherry Blossom Festival.**

---

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the Pink Panthers Drill Team of Millinocket was selected to participate in the Cherry Blossom Festival Parade in Washington, D.C., which will be held in April; and

Whereas, it is the intent of this Act to appropriate \$5,000 to help enable participation in this parade by the Pink Panthers Drill Team; and

Whereas, this appropriation must be made before April, 1983, a date which will fall before the normal

1 effective date of nonemergency Acts passed by the  
2 First Regular Session of the 111th Legislature; and

3 Whereas, in the judgment of the Legislature,  
4 these facts create an emergency within the meaning of  
5 the Constitution of Maine and require the following  
6 legislation as immediately necessary for the preser-  
7 vation of the public peace, health and safety; now,  
8 therefore,

9 Be it enacted by the People of the State of Maine as  
10 follows:

11 Pink Panthers Drill Team of Millinocket; appro-  
12 priation. There is appropriated from the General Fund  
13 to the Pink Panthers Drill Team of Millinocket the  
14 sum of \$5,000 to be used by the drill team and its  
15 staff to defray expenses incurred in participating in  
16 the 1983 Cherry Blossom Festival Parade to be held in  
17 Washington, D.C.

18 Emergency clause. In view of the emergency  
19 cited in the preamble, this Act shall take effect  
20 when approved.

21 STATEMENT OF FACT

22 This bill appropriates \$5,000 to the Pink  
23 Panthers Drill Team of Millinocket to help them par-  
24 ticipate in the 1983 Cherry Blossom Festival Parade  
25 to be held in Washington, D.C. The team, through its  
26 own efforts, will raise the remainder needed.
