tion for the previous year has been expired for more than 30 days, the expiration date of the renewal shall be at the end of the month, one year from the month of issuance of the previous registration. If the applicant provides satisfactory evidence and certifies in writing to the Secretary of State that the vehicle has not been operated on a public way during the period of the expired registration, the registration expiration date, upon renewal, is at the end of the month, one year from the month of issuance of the registration renewal.

- 3. Fleets. Any person who has a fleet of 5 or more motor vehicles of a particular classification may petition the Secretary of State for a common expiration date of all vehicles in the fleet.
- 4. Number plates. Number plates or a suitable device in lieu thereof furnished for the next registration period may be displayed on the vehicle on the first day of the month in which the current registration expires.

STATEMENT OF FACT

This bill provides a single system for determining the registration dates of all motor vehicles. Vehicles other than automobiles, motor trucks and truck tractors are presently all registered on the last day of February, regardless of the time of purchase. For example, a motorcycle must be registered in February, regardless of whether it was purchased the previous May or on January 25th of the same year.

This bill simply applies the same rules to all types of motor vehicles.
