24	STATEMENT OF FACT
25 26	The purpose of this amendment is to bring the bill into conformity with L.D. 881, already enacted
27	by the Legislature. L.D. 881 amended the Revised
28 29	Statutes, Title 25, to, among other things, change a definition in the provisions for police officer
30	training at the Criminal Justice Academy. The defi-
31 32	nition changed was that of "full-time" employment as it relates to the requirement that a law enforcement
33	officer receive training. Prior to the enactment of
34 35	L.D. 881, full-time law enforcement employment meant employment with the expectation of earning at least
35 36	\$4.000 per year. That bill raised that amount to

- 1 \$6,000 per year.
- The bill amends the Revised Statutes, Title 30, 3 to redefine what it means to be a part-time deputy. Clearly, the dividing line between full-time employment for the purposes of the Revised Statutes, Title 5 25, and part-time employment for the purposes of the Revised Statutes, Title 30, should be the same. This amendment reconciles these dividing lines.
