STATEMENT OF FACT

The purpose of this bill is to allow the Secretary of State to prepare ballots indicating the offices which will be voted upon in an election, without including the names of candidates. This ballot would be sent to overseas voters several months before the election so that they could enter the names of the candidates on the ballot and return the ballot to the town clerk of the voter's municipality. This method has been suggested by the Federal Voting Assistance Office to assist overseas voters in completing absentee ballots in a timely manner.
