21 figure "2" the underlined punctuation and figure '4'

13 "§96-B." in subsection 3 in the 2nd paragraph in the

15 the underlined word "agricultural" the underlined

17 STATEMENT OF FACT

18 This amendment extends the provisions of Title
19 39, section 96-B, providing for expedited decisions
20 on certain workers' compensation exemptions, to
21 aquacultural as well as agricultural employers.
22 Because these employers receive nearly identical
23 treatment under the present exemption section of the
24 law, it is desirable that they both receive the bene-
25 fit of the new expedited decision section.
