10 Amend the bill in section 1 in that part desig-11 nated "§32." in subsection 2 in the last line (page 12 2, line 12 in L.D.) by striking out the underlined punctuation and words ", timber, sod and forest and 13 nursery products" and inserting in their place the following underlined words 'and sod' 14 15

16 Further amend the bill in section 1 in that part designated "§32." by inserting after subsection 4 the 17 18 following:

5. Farm partnership. "Farm partnership" means 19 20 an association of 2 or more individuals formed for 21 the purpose of farming.

22 Further amend the bill in section 1 in that part designated "§32." in subsection 5 by striking out all 23 24 of paragraph A.

Further amend the bill in section 1 in that part designated " $\S32$." in subsection 5 by renumbering paragraphs B, C and D to be paragraphs A, B and C. 25 26 27

28 Further amend the bill in section 1 in that part designated "§32." by striking out all of subsection 29 30 6.

31 Further amend the bill in section 1 in that part designated "§32." by renumbering the subsections to 32 33 read consecutively.

Further amend the bill in section 1 in that part 34 designated "§33." in subsection 1 in the first and 35

Further amend the bill in section 1 in that part designated "<u>§33.</u>" in subsection 3 in the first line (page 3, line 35 in L.D.) by striking out the underlined word "person" and inserting in its place the underlined words 'corporation or partnership'

Further amend the bill in section 1 by striking out all of that part designated "<u>§34.</u>" and inserting in its place the following:

26 <u>'§34</u>. Exemptions

1. Family farm corporation or partnership. A

with the reporting requirements in section 33.

Further amend the bill in section 1 by striking 1 out all of that part designated "§36." and inserting 2 З in its place the following:

'§36. Penalties 4

Violation. Any corporation or partnership subject to this chapter which violates this law or the regulations adopted thereunder or which submits 8 a report which contains information that is false or misleading shall be subject to a civil penalty, payable to the State, of not more than \$50 for each day of the violation.

12 2. Warning. A corporation or partnership subject to this chapter which does not comply with the 13 law in a timely fashion shall first receive a written 14 warning from the Department of Agriculture, Food and 15 Rural Resources which will require presentation of 16 the information within 30 days. After the 30-day notice period is expired, penalties described in sub-17 18 19 section 1 shall be imposed.

STATEMENT OF FACT

21 This amendment requires corporations and partner-22 ships, which are not family farm corporations or farm partnerships, to file an annual report providing 23 information regarding ownership of agricultural land. 24 25 This annual report is submitted to the Department of 26 Agriculture, Food and Rural Resources.

Several other parts of the bill have been changed 27 28 to accomplish the purpose of this amendment, without 29 creating a burdensome reporting procedure or an 30 unreasonable penalty.
