SENATE AMENDMENT " A " to H.P. 898, L.D. 1150,  
8 Bill, "AN ACT to Amend and Supplement Certain Powers  
9 of Hospital Administrative District No. 1."

11 Amend the bill by inserting before the enacting  
12 clause the following:

13 'Emergency preamble. Whereas, Acts of the Legis-  
14 lature do not become effective until 90 days after  
15 adjournment unless enacted as emergencies; and

16 Whereas, there is an immediate need for Hospital  
17 Administrative District No. 1, the "district," a body  
18 politic and corporate established pursuant to Private  
19 and Special Law 1967, chapter 58, to be able to bor-  
20 row moneys for operating expenses, in order to ensure  
21 the continuous provision of medical care for the  
22 inhabitants of the district; and

23 Whereas, it is in the best interest of the  
24 inhabitants of the district to immediately permit the  
25 district to legally establish affiliated organiza-  
26 tions to engage in other activities deemed by the  
27 district necessary or desirable to improve provisions  
28 for the health and medical needs of the inhabitants  
29 of the district; and

30 Whereas, in the judgment of the Legislature,  
31 these facts create an emergency within the meaning of  
32 the Constitution of Maine and require the following  
33 legislation as immediately necessary for the preser-  
34 vation of the public peace, health and safety; now,
