17 AN ACT to Adjust Certain Motor Vehicle
18 Title Fees.

20 Be it enacted by the People of the State of Maine as
21 follows:

22 29 MRSA §2352, sub-§1, as repealed and replaced
23 by PL 1981, c. 492, Pt. E, §19, is repealed and the
24 following enacted in its place:

25 Sec. 1. Fees. The Secretary of State shall be
26 paid the following fees:

27 A. \$20:

28 (1) For certificate of title to an aban-
29 doned or unclaimed vehicle issued pursuant
30 to section 895-B or 2364-A.

31 B. \$15:

1 (1) For duplicate certificate of title or
2 certificate of salvage;

3 (2) For issuing a replacement vehicle iden-
4 tification number in accordance with
5 section 103.

6 C. \$10:

7 (1) For filing an application for a first
8 certificate of title, including no more than
9 2 security interests;

10 (2) For filing notice of a security inter-
11 est after the first certificate of title has
12 been issued;

13 (3) For certificate of title after a trans-
14 fer;

15 (4) For certificate of salvage issued, pur-
16 suant to section 2377;

17 (5) For any application filed subsequent to
18 an initial filing, including but not
19 limited to, adding or changing liens or lien
20 dates and correcting misinformation on pre-
21 vious application or titles, or both;

22 (6) An ordinary certificate of title issued
23 upon surrender of a distinctive certificate
24 issued pursuant to sections 2364-A, subsec-
25 tion 5, and section 2367, subsection 2;

26 (7) For a true or certified copy of
27 records-fee for each vehicle identification
28 number searched; and

29 (8) Special handling fee, to be paid in ad-
30 dition to the standard fee for services
31 rendered.

32 D. \$4:

33 (1) Routine commercial search and copy of
34 the records, no official certificate. Fee
35 for each vehicle identification number
36 searched.
