The above-described property is a portion 19 of the land conveyed to the State by George W. Spratt 20 21 by an instrument dated December 12, 1889, 22 recorded in the Penobscot registry of deeds in Volume 23 601, Page 24.

Any conveyance shall be made by quitclaim deed on those conditions and for such consideration as the Governor shall determine, in his discretion, to be appropriate.

If the estate conveyed is a fee simple determinable or a fee simple on condition subsequent, the limitations set forth in the Revised Statutes, Title 33, sections 101 and 103 shall not operate to defeat the State's possibility of reverter or its right of entry for condition broken.
