

1 STATEMENT OF FACT 2 The purpose of this amendment is to make some 3 technical changes to maintain consistency in the provisions of the bill and to provide additional 4 organizational record safeguards. 5 6 This amendment: 7 1. Changes the title of the Division of Travel 8 to the Division of Tourism; 9 Authorizes the Director of the State Develop-2. 10 ment Office to employ staff within the Division of 11 Tourism: 12 Authorizes the Division of Tourism to con-3. 13 tract for the staffing of information centers owned 14and operated by the State; 15 Requires the State Development Office to pre-4. 16 scribe standard accounting procedures to be used by 17 any organization receiving travel promotion matching 18 fund moneys; 19 5. Requires the organizations that receive 20 travel promotion matching fund moneys to provide ac-21 cess to those records relating to accounts and con-22 tracts funded by state travel promotion moneys for audit by the State; and 23 Requires the State Development Office to pro-6.

6. Requires the State Development Office to provide the Joint Standing Committee on State Government
with a progress report on the development and growth
of the Maine tourist industry.
