Amend the resolve in section 1, under the caption  
"1983 Tax" (page 2, line 13 in L.D.) by striking out  
the figure "\$561,092" and inserting in its place the  
figure '\$570,242'

Further amend the resolve in section 2, under the  
caption "1075-Sheriff" in that part relating to "Per-  
sonal Services" (page 3, line 37 in L.D.) by striking  
out the figure "197,719" and inserting in its place  
the figure '206,869'

Further amend the resolve in section 2, in that  
part relating to "TOTAL GENERAL FUND" (page 5, line 1  
in L.D.) by striking out the figure "\$711,905" and  
inserting in its place the figure '\$721,055'

Further amend the resolve in section 4, in that  
part relating to "Total Appropriations" (page 5, line  
41 in L.D.) by striking out the figure "\$786,905" and  
inserting in its place the figure '\$796,055'

Further amend the resolve in section 4, in that  
part relating to "Amount to be raised by taxation"  
(page 6, line 5 in L.D.) by striking out the figure  
"\$561,092" and inserting in its place the figure  
'\$570,242'

STATEMENT OF FACT

2           This amendment adds \$9,150 to the budget of the  
3 Sagadahoc County Sheriff's Department. The extra  
4 funds will be used to hire one additional patrol dep-  
5 uty beginning May 1, 1983. The \$9,150 figure repre-  
6 sents \$8,100 salary and \$1,050 fringe benefits.
