21 22 23	Emergency preamble. Whereas, Acts of the Legis- lature do not become effective until 90 days after adjournment unless enacted as emergencies; and
· 24 25	Whereas, it has become necessary to revise the salaries of certain county officials; and
26 27 28	Whereas, these revisions are vitally necessary at the earliest possible time this law can become effec- tive; and
29 30 31 32 33 34	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preser- vation of the public peace, health and safety; now, therefore,

1 Be it enacted by the People of the State of Maine as 2 follows:
