26 27 28 29	Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and
30 31	Whereas, 1983 marks the 100th anniversary of the founding of the Town of Old Orchard Beach; and
32 33	Whereas, an event of great significance has been planned to commemorate this historic development; and

Whereas, this legislation is vitally necessary to the town people of Old Orchard Beach and their planned centennial; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore, be it

Town of Old Orchard Beach; "Centennial Way" designated. Resolved: That the Saco Spur from Route 1 to its intersection with Ocean Park Road be designated as "Centennial Way" during the year 1983 to commemorate the 100th anniversary of the founding of the Town of Old Orchard Beach; and be it further

Resolved: That the Commissioner of Transportation be authorized to erect appropriate signs furnished by the town at such locations and appurtenances to the way as the Department of Transportation and the town may select.

Emergency clause. In view of the emergency cited in the preamble, this resolve shall take effect when approved.

## STATEMENT OF FACT

This new draft authorizes the Town of Old Orchard Beach, with the concurrence of the City of Saco, to name the Saco Spur from Route 1 to its intersection with Ocean Park Road "Centennial Way" for one year to commemorate Old Orchard Beach's 100th anniversary.
