Amend the Bill in that part designated "§1642."  
in subsection 1 in the last 3 lines (page 2, lines 11  
to 13 in L.D.) by striking out the underlined punctu-  
ation and words ", and may mean such other adminis-  
trative units of State Government as are defined from  
time to time"

Further amend the bill in that part designated  
"§1642." by inserting before subsection 3 the follow-  
ing:

'3. Related health and medical ser-  
vices. "Related health and medical services" means  
services that are administered by the Department of  
Human Services, Bureau of Health and Bureau of Medi-  
cal Services, including Medicaid and health block  
grants, and that are either a health service  
integrally related to a social service or a major  
source of funds for a social service.'

Further amend the bill in that part designated  
"§1642." in subsection 3 in the last 3 lines from the  
end (page 2, lines 22 to 24 in L.D.) by striking out  
all of the underlined words and punctuation "or  
winterization service operated by a department  
utilizing state-administered funds, except income  
supplementation, health and medical services" and  
inserting in their place the following underlined  
words and punctuation 'weatherization or other social  
service that may be defined in the future, and that  
is operated by a department utilizing  
state-administered funds, including related health  
and medical services and excepting income supple-  
mentation programs'

HOUSE AMENDMENT "A" to H.P. 1255, L.D. 1668

1 Further amend the bill in that part designated  
2 "§1642." by renumbering the subsections to read con-  
3 secutively.

4 Further amend the Bill in that part designated  
5 "§1643." by striking out all of subsection 1 and  
6 inserting in its place the following:

7 '1. Development of plan. The departments, as  
8 defined in section 1642, shall develop the Maine  
9 Social Services Plan in accordance with any executive  
10 order issued by the Governor on June 6, 1983. Plan  
11 documents shall be published as specified by that  
12 order's timetable and in subsection 2.'

13 Further amend the Bill in that part designated  
14 "1643." in subsection 2, paragraph A in the 7th line  
15 (page 3, line 10 in L.D.) by striking out the under-  
16 lined word "cost" and inserting in its place the  
17 underlined word 'costs'

18 Further amend the Bill in that part designated  
19 "§1643." in subsection 2, paragraph C in the 3rd line  
20 (page 3, line 32 in L.D.) by striking out the under-  
21 lined words "in accordance" and inserting in their  
22 place the underlined word 'concurrently'
