7 HOUSE AMENDMENT "F" to S.P. 592, L.D. 1710, 8 Bill, "AN ACT to Establish County Budget Committees."

9 Amend the bill by inserting after section 3 the 10 following:

11 'Sec. 4. 30 MRSA §253-A, as enacted by PL 1973, 12 c. 229, §2, is amended to read:

13 §253-A. Specific line categories

14 The **begistature** <u>county commissioners</u> shall have 15 the power to change or alter specific line categories 16 within the county estimates.'

Further amend the bill in section 4 in that part designated "<u>§253-B.</u>" in the 4th line (page 4, line 31 in L.D.) by striking out the underlined words "<u>budget</u> <u>committee</u>" and inserting in their place the underlined words 'county commissioners'

22 Further amend the bill in section 5 in that part designated "§253-C." in the first paragraph in the 23 6th line (page 5, line 6 in L.D.) by striking out the 24 underlined words "budget committee" and inserting in their place the underlined words 'county commission-25 26 ers' and in the next to the last line by striking out the word "member" and inserting in its place the stricken out word 'member' and in the last line by 27 28 29 striking out the underlined words "budget committee" 30 31 and inserting in their place the underlined words 32 'county commissioners'

Further amend the bill in section 6 in that part designated "<u>§254.</u>" in the 2nd and 3rd lines (page 5, lines 28 and 29 in L.D.) by striking out all of the underlined words "by the budget committee" and in the

9th line (page 5, line 35 in L.D.) by inserting after the word and punctuation "September." the following underlined words and punctuation 'This apportionment shall also reflect the effect of the county tax on the municipal mil rate.'

6 Further amend the bill in section 6 in that part designated "§254." in the first paragraph in the 6th 7 line from the end (page 6, line 1 in L.D.) by insert-8 9 ing after the word and punctuation "collection." the underlined words and punctuation 'Any 10 following 11 municipality which assesses any tax which includes an assessment representing that municipality's portion 12 of the county tax shall indicate on the tax bill that 13 portion of the assessment which is to be used for 14 county tax purposes. 15

16 Further amend the bill in section 7 in the 3rd 17 line (page 6, line 12 in L.D.) by striking out the 18 underlined word "COMMITTEE"

Further amend the bill in section 7 in that part designated " $\S1401$ ." in the 4th and 5th lines (page 6, lines 16 and 17 in L.D.) by striking out all of the 19 20 21 lines 16 and 17 in L.D.) by striking out all of the underlined words and punctuation ", which shall first receive approval of a budget committee" and in the 7th line (page 6, line 19 in L.D.) by striking out the underlined word "to" and inserting in its place the underlined word 'of' and in the next to the last line (page 6, line 21 in L.D.) by inserting after the underlined words "budgets to" the following under-22 23 24 25 26 27 28 29 lined words 'the county commissioners with the advice 30 of'

Further amend the bill in section 7 in that part designated "<u>§1403.</u>" in subsection 1, paragraph B in the 7th line from the end (page 7, line 32 in L.D.) by striking out the underlined word "<u>weighed</u>" and inserting in its place the underlined word '<u>weighted</u>'

36 Further amend the bill in section 7 in that part 37 designated "<u>§1403.</u>" by inserting after subsection 1 HOUSE AMENDMENT " $\mathcal{F}$ " to S.P. 592, L.D. 1710

1 the following:

2 '2. Responsibilities. It is the responsibility 3 of the county budget committee to review the budget 4 estimates prepared by the county commissioners and to 5 make recommendations to the county commissioners con-6 cerning a final county budget.'

7 Further amend the bill in section 7 in that part 8 designated "<u>§1403.</u>" by renumbering the subsections to 9 read consecutively.

10 Further amend the bill in section 7 in that part designated "<u>§1405.</u>" in subsection 2 in the first 11 paragraph in the next to the last line (page 9, line 12 30 in L.D.) by striking out all of the underlined 13 14 words and punctuation "may increase, decrease, alter or revise" and inserting in their place the under-15 lined words and punctuation 'shall, within 30 days of 16 17 receipt of the proposed budget, make recommendations 18 to the county commissioners concerning the proposed 19 budget, including increases, decreases, alterations 20 or revisions to'

Further amend the bill in section 7 in that part designated "§1405." in subsection 2 in paragraph A in the first and 2nd lines (page 9, lines 32 and 33 in L.D.) by striking out the underlined words "enter into its minutes" and inserting in their place the underlined words 'include with its recommendations'

27 Further amend the bill in section 7 in that part designated "§1405." in subsection 3 in the first line 28 (page 10, line 1 in L.D.) by striking out the under-lined words "budget committee" and inserting in their 29 30 31 place the underlined words and punctuation 'county 32 commissioners, after receiving the recommendations of the budget committee, ' and in the 8th line (page 10, 33 34 line 8 in L.D.) by inserting after the underlined 35 word "budget" the underlined punctuation and words ', along with the recommendations of the budget commit-36 tee, ' and in the last line (page 10, line 13 in L.D.) 37

by inserting after the underlined word "budget" the underlined words 'and the budget committee recommendations.'

4 Further amend the bill in section 7 in that part 5 designated "<u>§1405.</u>" in subsection 4 by striking out 6 all of the first paragraph and inserting in its 7 place the following:

8 <u>'4. Adoption of budget. After completion of the</u> 9 <u>public hearing, the county commissioners may further</u> 10 <u>increase, decrease, alter and revise the proposed</u> 11 <u>itemized budget, provided that</u>:

12A. The county commissioners shall enter into13their minutes a statement of the basis for any14rejection of any recommendation of the budget15committee; and

16B. The total estimated revenues, together with17the amount of county tax to be levied, shall18equal the total estimated expenditures.

19 The proposed itemized budget shall be finally adopted 20 by a majority vote of the county commissioners at a 21 duly called meeting not later than the end of the 22 county's fiscal year. The approved budget shall be 23 the final authorization for the assessment of county 24 taxes. The county tax authorized shall be appor-25 tioned and collected in accordance with section 254.

Further amend the bill in section 7 in that part designated "<u>§1406.</u>" in the 4th line from the end (page 11, line 2 in L.D.) by inserting after the underlined word and punctuation "<u>it</u>," the underlined words '<u>make recommendations to the county commission-</u> <u>ers who shall</u>' and in the last line (page 11, line 5 in L.D.) by striking out the underlined words "<u>budget</u> <u>committee's</u>" and inserting in their place the underlined words '<u>county commissioners</u>'
