Amend the bill in section 6 in that part designat-  
ed "§969." in subsection 5 by striking out all of  
the next to the last sentence (page 15, lines 31 to  
34 in L.D.) and inserting in its place the following:  
'The authority shall determine the qualifications,  
duties and compensation of its employees.'

Further amend the bill in section 6 in that part  
designated "§972." by striking out all of subsections  
2 and 3 and inserting in their place the following:

'2. Appoint professional staff. Appoint profes-  
sional staff to the Finance Authority of Maine and to  
the divisions within the authority. The profession  
staff shall be unclassified state employees and shall  
serve at the pleasure of the chief executive officer.  
One professional staff member shall be a veteran and,  
among other duties, shall be assigned to work with  
the Maine Veterans' Small Business Loan Program. The  
professional staff shall be compensated at a rate  
determined by the authority;

3. Clerical staff appointed in accordance with  
the Personnel Law. Appoint, subject to the Person-  
nel Law, clerical staff who shall be classified  
employees;

1 STATEMENT OF FACT

2 The purpose of this amendment is to establish the  
3 Finance Authority of Maine as a state agency with

6 the general manager, are classified employees.
