6 STATEMENT OF FACT

The purpose of this bill is to provide for the establishment of temporary guardianships in emergency situations, so incapacitated persons can receive treatment or be placed as soon as possible. bill recognizes that there is sometimes an immediate need for action, but that the Judges of Probate sit on a part-time basis, occasionally as infrequently as once each month.
