10 11 12 13	Amend the bill in section 1 in subsection 30-A in the last line (page 1, line 26 in L.D.) by striking out the underlined word " <u>family</u> " and inserting in its place the underlined word ' <u>genus</u> '
14 15	Further amend the bill by inserting after section 1 the following:
16 17 18	'Sec. 2. 12 MRSA §6074, sub-§1, ¶A, as enacted by PL 1977, c. 661, §5, is repealed and the following enacted in its place:
19	A. Pacific salmon.
20 21	Sec. 3. 12 MRSA §6074, sub-§3, as amended by PL 1979, c. 622, §1, is further amended to read:
22 23 24 25 26 27 28 29 30	3. Filing fee. Each application shall include a nonrefundable filing fee of \$50. The fee may be waived for research activity by institutions or organizations financed in whole or part by state funding. No filing fee shall may be required for applying for a special license for raising and selling eehe Pacific salmon. No filing fee may be required from a municipality applying for a special license for using a hydraulic dredge under section 6623.
31 32	Sec. 4. 12 MRSA §6074, sub-§5, as amended by PL 1979, c. 622, §2, is further amended to read:
33 34	5. <u>Fees.</u> The annual fee for a special license shall be \$25. An annual fee of \$10 shall be paid for

each individual after the first individual. No license fee shall may be required for a special license for raising and selling eehe Pacific salmon. No license fee may be required from a municipality for a special license for using a hydraulic dredge under section 6623.'

7 Further amend the bill in section 2 in that part 8 designated "§6554." in subsection 4 in the next to 9 the last line (page 2, line 11 in L.D.) by striking 10 out the underlined words "a valid permit" and insert-11 ing in their place the following: 'all valid leases, 12 special licenses or permits necessary'

13 Further amend the bill by inserting before the 14 Statement of Fact the following:

15 '<u>5. Recommendations; commissioner.</u> Nothing in 16 this chapter shall may prohibit the commissioner from 17 recommending to the Legislature changes in the limit 18 on Pacific salmon that may be taken by hook and line 19 with a single hook.'

20 Further amend the bill by renumbering the sec-21 tions to read consecutively.

STATEMENT OF FACT

23 The purpose of this amendment is to change the 24 term "coho" salmon to "Pacific" salmon wherever it 25 occurs. This is consistent with the intent of the 26 original bill. The amendment further clarifies the 27 Legislature's ability to reconsider the bag limit on 28 "Pacific" salmon sport fishing in the future.
