7 COMMITTEE AMENDMENT "A" to H.P. 1533, 8 L.D. 2016, Bill, "AN ACT to Establish a Commercial 9 Tag for Atlantic Salmon."

10 Amend the bill by striking out all of section 2 11 and inserting in its place the following:

12 'Sec. 2. 12 MRSA §6253, sub-§5 is enacted to 13 read:

5. Regulations; Atlantic salmon. When requested by the commission, the Commissioner of Marine Re-sources, within the limits of section 6171, may promulgate regulations as necessary to conserve At-14 15 16 17 18 lantic salmon with the restriction that the regula-19 tions apply only to coastal waters designated in sec-20 tion 6255, subsection 2, and that the regulations 21 have a duration of no more than 72 hours. The advice 22 and consent of the advisory council shall be re-23 quired.

Further amend the bill in section 3 in that part designated "§6255." in subsection 1 in the 4th line (page 2, line 19 in L.D.) by striking out the underlined word "fish" and inserting in its place the underlined words 'Atlantic salmon'

Further amend the bill in section 3 in that part designated "§6255." in subsection 2 by striking out all of paragraphs I and J and inserting in their place the following:

33 'I. Penobscot River, above the upstream side of 34 the Joshua Chamberlain Bridge in Bangor;
35 J. Ducktrap River, above the 3 red posts set on 36 the shores approximately 1,000 feet downstream

1 from the U.S. Route 1 bridge; Saco River, above a line extending from the 2 Κ. 3 outer extremity of the Camp Ellis breakwater in Saco to the outer extremity of the Hills Beach 4 5 breakwater in Biddeford; and L. St. Croix River, above the international bridge between Calais and St. Stephen, New б 7 New 8 Brunswick. 9 Further amend the bill in section 3 in that part designated "§6255." in subsection 6 in the first line 10 11 (page 4, line 4 in L.D.) and in the 3rd line (page 4, 12 line 6 in L.D.) by striking out the underlined words 13 "sea run" 14 Further amend the bill in section 3 in that part designated "§6255." by inserting after subsection 6 15 16 the following: 7. Exceptions. Those persons and individuals 17 licensed for the aquaculture of Atlantic salmon shall 18 19 be exempt from this section other than they shall report to the Atlantic Sea Run Salmon Commission the number, weight and locations sold to, of all Atlantic salmon within the commission's jurisdiction. The commission shall abide by the confidentiality regula-20 21 22 23 24 tions adopted pursuant to section 6173. 25 Further amend the bill in section 3 in that part designated "§6255." by renumbering the subsections to 26 27 read consecutively. Further amend the bill by inserting after section 28 29 4 the following: 'Sec. 5. 12 MRSA §6553, sub-§6, as enacted by PL 30 1981, 662, §2, is amended to read: 31 32 6. Bag limit.
