designated "§1662." in subsection 1, paragraph B in  
the 2nd line (page 2, line 16 in L.D.) by inserting  
after the underlined word "medical" the underlined  
word and punctuation ', psychological'

designated "§1662." by striking out all of subsection  
3 and inserting in its place the following:

'3. Local match. Any rape crisis center which

funding or in-kind resources in accordance with the  
Department of Human Services' policies.'
