line 8 in L.D.) by striking out the following: "5
days one day" and inserting in their place the fol-
lowing: '5 3 days'

1 Further amend the Bill in section 2 in that part
2 designated "§62." in the first sentence, first line
3 (page 3, line 1 in L.D.) by striking out the under-
4 lined word "first" and inserting in its place the
5 following: '3rd'

6 STATEMENT OF FACT

7 This amendment changes the waiting period between
8 filing of intentions to marry and issuance of a mar-
9 riage license from 5 days to 3 days. The original
10 bill had shortened the period to only one day. The
11 original bill proposed permitting Superior Court jus-
12 tices, as well as District Court judges and Probate
13 Court judges, to waive the waiting period. This
14 amendment also proposes allowing Supreme Judicial
15 Court justices to waive the waiting period.
