7 COMMITTEE AMENDMENT " A " to S.P. 814, 8 L.D. 2191, Bill, "AN ACT to Reallocate Unsold Bonds 9 as Previously Authorized by Private and Special Law 10 of 1971, Chapter 140, for the Development and Im-11 provement of State Park Facilities."

12 Amend the Bill by inserting after section 2 the 13 following:

14 'Sec. 3. Issue of bonds to provide for capital 15 improvements, construction, renovations, equipment 16 and furnishings for various state departments. The 17 Treasurer of State is authorized, under the direction 18 of the Governor, to issue from time to time regis-19 tered bonds in the name and behalf of the State to an 20 amount not exceeding \$3,090,000 for the purpose of 21 raising funds to provide for such capital improvements, construction, renovations, equipment and fur-22 nishings as authorized by section 6. The bonds shall be deemed a pledge of the faith and credit of the State. The bonds shall not run for a longer period 23 24 25 than 5 years from the date of the original issue thereof. Any issuance of bonds may contain a call 26 27 28 feature at the discretion of the Treasurer of State 29 with the approval of the Governor.'

30 Further amend the Bill in section 4 in the 2nd 31 line (page 7, line 37 in L.D.) by striking out the 32 figure "3" and inserting in its place the figure '4'

Further amend the Bill in section 6 in the first lines (page 8, lines 7 to 9 in L.D.) by striking out the following: "Sec. 6. Statutory referendum procedure; submission at general election; form of quiestion; effective date." and inserting in its place the following: 'Sec. 6. Statutory referendum

19	tions to read consecutively.
20 21	Further amend the Bill by striking out all of the emergency clause.
22 23	Further amend the Bill by inserting at the end before the statement of fact the following:
24	'FISCAL NOTE
25	The total cost of this bill is estimated to be
26	\$422,186. This amount includes interest calculated at
27	8.25% over 5 years.'
