Amend the bill in section 2 in that part designated "§5152." in subsection 2 in the 6th line (page 2, line 13 in L.D.) by striking out the underlined word "in" and inserting in its place the underlined words 'on the site of'

Further amend the bill in section 3 in that part designated "§5153." in the first paragraph in the 3rd line (page 2, line 28 in L.D.) by inserting after the underlined word and punctuation "Aging," the following:

'the Maine State Housing Authority, the Farmers' Home Administration or other housing agency financing the congregated housing facility,'

Further amend the bill in section 4 in that part designated "§5154." by striking out all of the first 2 lines (page 3, lines 5 and 6 in L.D.) and inserting in their place the following:

Further amend the bill in section 4 in that part designated "§5154." in the first paragraph, in the 2nd and 3rd lines (page 3, lines 8 and 9 in L.D.) by striking out the underlined words "relating to the certification of" and inserting in their place the underlined words 'for a voluntary certification program for'

STATEMENT OF FACT

12 This amendment clarifies where the congregate  
13 housing services program is delivered. It also spec-  
14 ifies that housing agencies providing funding are in-  
15 cluded in the group which should advise the Bureau of  
16 Maine's Elderly in the administration of the program.  
17 Lastly, since the certification program is changed to  
18 be a voluntary one, changes have been made in the  
19 language to indicate that certificates and an annual  
20 review will only affect those programs which choose  
21 to participate in the certification process.
