Amend the bill by inserting after the Title the

13

following:

14

'Emergency preamble. Whereas, Acts of the Legis-

15

lature do not become effective until 90 days after

16

adjournment unless enacted as emergencies; and

17

Whereas, there is an immediate need for the con-

18

struction of new court facilities in the Portland and

19

Bath-Brunswick areas; and

20

Whereas, there is already scheduled an election

21

in June 1984, at which time the electorate could vote

22

upon ratification of the bond issue authorized in

23

this Act; and

24

Whereas, if the bond issue is ratified in June

25

1984, construction could begin during the 1984 con-

26

struction season; and

27

Whereas, in the judgment of the Legislature,

28

these facts create an emergency within the meaning of

29

the Constitution of Maine and require the following

30

legislation as immediately necessary for the preser-

31

vation of the public peace, health and safety; now,

therefore,'

Further amend the bill in section 1, in the 5th

34

line (page 1, line 34 in L.D.) by striking out the

35

words "serial coupon" and inserting in their place

36

the word 'registered'

1 Further amend the bill in section 1, in the 5th
2 line from the end (page 2, line 5 in L.D.) by strik-
3 ing out the figure "20" and inserting in its place
4 the figure '10'

5 Further amend the bill in section 10 in the 2nd
6 line (page 3, line 19 in L.D.) by striking out the
7 words "effective date" and inserting in their place
8 the words 'emergency clause'

9 Further amend the bill in section 10 in the 3rd
10 paragraph, in the 3rd line from the end (page 4, line
11 5 in L.D.) by inserting after the word "and" the fol-
12 lowing: ', in view of the emergency set out in the
13 preamble,'

14 Further amend the bill by inserting at the end
15 before the statement of fact the following:

16 'Fiscal Note

17 The total cost is estimated to be \$8,775,530.
18 This amount includes interest calculated at 8.41%
19 over 10 years.'

20 STATEMENT OF FACT

21 The purpose of this amendment is to change life
22 of bonds from 20 years to 10 years and add an emer-
23 gency to the bill.
