SENATE AMENDMENT "A " to COMMITTEE AMENDMENT "A"
to H.P. 1743, L.D. 2297, Bill, "AN ACT Making Ap-
propriations from the General Fund to Implement Cer-
tain Recommendations of the Governor's Commission on
the Status of Education in Maine for the Fiscal Years
Ending June 30, 1984, and June 30, 1985."

Amend the amendment by inserting after the title
the following:

'Amend the bill by inserting at the beginning of
the first line after the enacting clause the follow-
ing: 'Sec. 1.'

Further amend the amendment by striking out all
of the first 11 lines after the title (page 1, lines
13 to 23 in amendment) and inserting in their place
the following:

'Further amend the bill in the appropriation un-
der the caption "EDUCATIONAL AND CULTURAL SERVICES,
DEPARTMENT OF" by striking out all of those parts re-
lating to General Purpose Aid for Local Schools;
Vocational-Technical Institute - Central Maine;
Vocational-Technical Institute - Eastern Maine;
Vocational-Technical Institute - Kennebec Valley;
Vocational-Technical Institute - Northern Maine;
Vocational-Technical Institute - Southern Maine;
Vocational-Technical Institute - Washington County'

Further amend the amendment by inserting after
the first 11 lines after the title the following:

'Further amend the bill by inserting after that
part relating to "Vocational-Technical Institute -
Washington County" the following:'
