HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A"
8 to H.P. 1772, L.D. 2340, Bill, "AN ACT To Authorize
9 a General Fund Bond Issue in the Amount of
10 \$15,735,000 to Plan, Construct and Equip Pollution
11 Abatement Facilities and to Abate, Clean Up and Miti-
12 gate Threats to Public Health and the Environment
13 from Uncontrolled Hazardous Substance Sites."

Amend the amendment by striking out all of the
15 first paragraph after the title and inserting in its
16 place the following:

17

'Amend the bill in section 1 by striking out all
18 of the first sentence and inserting in its place the
19 following:

20

'The Treasurer of State may, under the direction of
21 the Governor, issue from time to time registered
22 bonds in the name and in behalf of the State to an
23 amount not exceeding \$15,735,000, of which \$3,235,000
24 may be issued on the effective date of this Act to
25 abate, clean up and mitigate threats to public health
26 and the environment from uncontrolled hazardous sub-
27 stance sites, as authorized by sections 6 and 7 and
28 of which \$12,500,000 may be issued after July 1,
29 1986, unless the Legislature establishes an earlier
30 date, by 2/3 vote of each House of the members
31 present and voting, to provide funds to plan, con-
32 struct and equip pollution abatement facilities.'
