HOUSE AMENDMENT "A" to SENATE AMENDMENT "A" to  
S.P. 889, L.D. 2404, Bill, "AN ACT to Revise the  
Wood Measurement Law."

Amend the amendment by striking out all of the  
first 2 paragraphs after the title and inserting in  
their place the following:

'Amend the bill in section 2 in that part desig-  
nated "§2361-A." by striking out all of subsection 1  
and inserting in its place the following:

'1. Agreement of the parties. "Agreement of the  
parties" means the mutual agreement of the parties or  
their authorized representatives, and is distin-  
guished from a unilateral condition imposed by any  
party to the agreement. A party is a company or in-  
dividual buying wood, a contractor, an individual  
providing services described in subsection 7 or an  
authorized employee representative negotiating on be-  
half of the individual providing services.'

Further amend the amendment by striking out all  
of the 7th and 8th paragraphs after the title and in-  
serting in their place the following:

'Further amend the bill in section 6 in that part  
designated "§2363-A." in subsection 3, paragraph A,  
subparagraph (b) in the 4th line (page 4, line 32 in  
L.D.) by inserting after the underlined word  
"services" the following: 'if a request is made in  
writing by the employee, an authorized employee rep-  
resentative or by the state sealer'

Further amend the amendment by inserting before  
the 2nd paragraph before the statement of fact the

2 'Further amend the bill in section 7 in that part  
3 designated "§2364-A." by inserting after subsection 3  
4 the following:

5 '4. Specification for properly prepared wood.  
6 Companies or individuals buying wood for processing  
7 shall give contractors or landowners written specifi-  
8 cations for properly prepared wood. No deductions  
9 for quality or future merchantability may be made for  
10 properly prepared wood, meeting the written specifi-  
11 cations which have been provided by the companies and  
12 individuals buying the wood.'

13 Further amend the bill in section 8 in that part  
14 designated "§2365-A." in the first paragraph in the  
15 3rd line (page 7, line 3 in L.D.) by inserting after  
16 the underlined word and punctuation "licensing." the  
17 following: 'Annual license fees shall not exceed \$25  
18 and funds collected shall cover the expenses involved  
19 in administering the licensing process and other  
20 costs related to the administration of this section.'

21 Further amend the bill in section 8 in that part  
22 designated "§2365-A." by striking out all of the 2nd  
23 paragraph and inserting in its place the following:

24 'Fees collected under this section shall be depos-  
25 ited in a separate account which shall not lapse.'
