- 'Further amend the bill in section 7 in that part designated "§2364-A." by inserting after subsection 3 the following:
- '4. Specification for properly prepared wood.
  Companies or individuals buying wood for processing
  shall give contractors or landowners written specifications for properly prepared wood. No deductions
  for quality or future merchantability may be made for
  properly prepared wood, meeting the written specifications which have been provided by the companies and individuals buying the wood.
- Further amend the bill in section 8 in that part designated "§2365-A." in the first paragraph in the 3rd line (page 7, line 3 in L.D.) by inserting after the underlined word and punctuation "licensing." the following: 'Annual license fees shall not exceed \$25 and funds collected shall cover the expenses involved in administering the licensing process and other costs related to the administration of this section.'
- Further amend the bill in section 8 in that part designated "§2365-A." by striking out all of the 2nd paragraph and inserting in its place the following:
- Fees collected under this section shall be deposited in a separate account which shall not lapse.
