COMMITTEE AMENDMENT "B" to H.P. 1825,
L.D. 2420, Bill, "AN ACT to Appropriate Funds to the
University of Maine to Implement Collective Bargain-
ing Agreements."

Amend the bill by striking out everything after
the title and before the statement of fact and in-
serting in its place the following:

'Emergency preamble. Whereas, Acts of the Legis-
lature do not become effective until 90 days after
adjournment unless enacted as emergencies; and

Whereas, the 90-day period may not terminate un-
til after the beginning of the next fiscal year; and

Whereas, certain obligations and expenses inci-
dent to tentative collective bargaining agreements
reached between the University of Maine and its em-
ployees will become due and payable immediately; and

Whereas, funding must be provided immediately if
those obligations and expenses are to be met; and

Whereas, in the judgment of the Legislature,
these facts create an emergency within the meaning of
the Constitution of Maine and require the following
legislation as immediately necessary for the preser-
vation of the public peace, health and safety; now,
therefore,

Be it enacted by the People of the State of Maine as
follows:

Sec. 1. PL 1983, c. 477, Pt. A, under the cap-
tion "UNIVERSITY OF MAINE, BOARD OF TRUSTEES" is re-
pealed and the following enacted in its place:

10 Sec. 2. Appropriation. The following funds are
11 appropriated from the General Fund to carry out the
12 purposes of this Act.

16 These funds, together
17 with the \$4.6 million
18 appropriated in the Part
19 1 Budget last session,
20 are to be used to fund
21 the 60% General Fund
22 share of the collective
23 bargaining agreements

25 versity of Maine and its
26 employees.

27 Emergency clause. In view of the emergency
28 cited in the preamble, this Act shall take effect
29 when approved.'
