11 12 13	Amend the bill by striking out everything after the title and before the statement of fact and in- serting in its place the following:
14 15 16	'Emergency preamble. Whereas, Acts of the Legis- lature do not become effective until 90 days after adjournment unless enacted as emergencies; and
17 18	Whereas, the 90-day period may not terminate until after the beginning of the next fiscal year; and
19 20 21 22	Whereas, certain obligations and expenses incident to tentative collective bargaining agreements reached between the University of Maine and its employees will become due and payable immediately; and
23 24	Whereas, funding must be provided immediately if those obligations and expenses are to be met; and
25 26 27 28 29 30	Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,
31 32	Be it enacted by the People of the State of Maine as follows:
33 34 35	Sec. 1. PL 1983, c. 477, Pt. A, under the caption "UNIVERSITY OF MAINE, BOARD OF TRUSTEES" is repealed and the following enacted in its place:

COMMITTEE AMENDMENT " $oldsymbol{eta}$ " to H.P. 1825, L.D. 2420

1 STATEMENT OF FACT

2 The purpose of this amendment is to provide for 3 60% of the funding to implement collective bargaining agreements between the University of Maine and its 4 employees. The university's operating budget is nor-5 mally funded 60% from the General Fund and 40% from other funds within the university system and this 6 7 8 amendment seeks to retain that proportional share of 9 the cost. This amendment also deappropriates the funding for the University of Maine campus 10 Lewiston, the Board of Trustees of the university has 11 voted not to establish that campus and the funds, 12 therefore, can not be used for that purpose. 13
