HOUSE AMENDMENT "E" to H.P. 1858, L.D. 2459,  
Bill, "AN ACT to Implement Certain Recommendations of  
the State Compensation Commission."

Amend the bill in Part B, in section 1, in that  
part designated "§2." in the first paragraph, in the  
3rd and 4th lines (page 2, lines 14 and 15 in L.D.)  
by striking out the following: "1982 1984 and there-  
after, shall receive \$6,500 \$7,500 in the first year  
and \$3,500 \$4,000" and inserting in its place the  
following: '1982 and thereafter, shall receive \$6,500  
in the first year and \$3,500'

Further amend the bill in Part B, in section 1,  
in that part designated "§2." in the 4th paragraph in  
the 6th line (page 3, line 31 in L.D.) by striking  
out the following: "and," and inserting in its place  
the following: 'and'

Further amend the bill in Part B, in section 1,  
in that part designated "§2." in the 4th paragraph in  
the last 3 lines (page 3, lines 34 to 36 in L.D.) by  
striking out the following: "and the Senate and House  
chairmen of the joint standing committees shall re-  
ceive an additional 6 1/4% above regular  
compensation"

Further amend the bill in Part B, in section 1,  
in that part designated "§2." in the 7th paragraph,  
in the 4th line (page 4, line 8 in L.D.) by striking  
out the underlined figure "\$77" and inserting in its  
place the underlined figure '\$65'

Further amend the bill in Part B, in section 1,  
in that part designated "§2." in the 9th paragraph,  
in the 9th line (page 4, line 30 in L.D.) by striking
