HOUSE AMENDMENT "B" to SENATE AMENDMENT "A" to
H.P. 1858, L.D. 2459, Bill, "AN ACT to Implement
Certain Recommendations of the State Compensation
Commission."

Amend the amendment by inserting before the 6th
paragraph after the title (page 1, line 23 in amend-
ment) the following:

'Further amend the bill in Part B in section 1 in
that part designated "§2." in the first paragraph in
the 3rd line (page 2, line 14 in L.D.) by striking
out the following: "~~1982~~ 1984" and inserting in its
place the following: '1982'

Further amend the bill in Part B in section 1 in
that part designated "§2." in the first paragraph in
the 3rd and 4th lines (page 2, lines 14 and 15 in
L.D) by striking out the following: "~~\$6,500~~ \$7,500"
and inserting in its place the following: '\$6,500'

Further amend the bill in Part B in section 1 in
that part designated "§2." in the first paragraph in
the 4th line (page 2, line 15 in L.D.) by striking
out the following: "~~\$3,500~~ \$4,000" and inserting in
its place the following: '\$3,500'

Further amend the amendment by inserting before
the 9th paragraph after the title (page 2, line 17 in
amendment) the following:

'Further amend the bill in Part B in section 1 in
that part designated "§2." in the 5th paragraph from
the end in the 4th line (page 4, line 8 in L.D.) by
striking out the underlined figure "\$77" and insert-
ing in its place the underlined figure '\$65'

1 Further amend the bill in Part B in section 1 in
2 that part designated "§2." in the 3rd paragraph from
3 the end in the 9th line (page 4, line 30 in L.D) by
4 striking out the following: "\$35 \$50" and inserting
5 in its place the following: '\$35'

6 Further amend the amendment by inserting before
7 the 10th paragraph after the title (page 2, line 31
8 in amendment) the following:

9 'Further amend the bill in Part B in section 1 in
10 that part designated "§2." in the last paragraph in
11 the 4th line (page 5, line 9 in L.D.) by striking out
12 the following: "~~thirty~~ fifty" and inserting in its
13 place the following: 'thirty'

14 Further amend the bill in Part B in section 1 in
15 that part designated "§2." in the last paragraph in
16 the 3rd line from the end (page 5, line 11 in L.D.)
17 by striking out the following: "\$70 \$80" and insert-
18 ing in its place the following: '\$70'

19 Further amend the amendment by striking out all
20 of the 6th and 7th lines from the end before the
21 statement of fact (page 11, lines 4 and 5 in amend-
22 ment) and inserting in their place the following:

23	'Personal Services	\$ 3,884
24	All Other	74,400'

25 Further amend the amendment by adjusting the to-
26 tals accordingly.
