## STATEMENT OF FACT

18 This amendment adds as a reason for challenging a 19 voter or ballot that the person voted using the name 20 of another person. This is a class D crime.

HOUSE AMENDMENT " ${\cal B}$ " to COMMITTEE AMENDMENT "A" to S.P. 32, L.D. 33

1 This amendment removes the restrictions placed on 2 candidates concerning serving as witnesses. Under 3 this amendment, a candidate who is a notary or other 4 official may serve as a single witness. If a candi-5 date is not a notary or other official, he may serve 6 as one of 2 witnesses. This is treating the candidate 7 the same as anyone else.
