25 26 27 28 29 30 31 32 33	It is the intent of the Legislature to encourage cooperation among state departments and to facilitate and encourage public participation in social service policy making by requiring the submission of a Maine Social Services Plan Report to the joint standing committee of the Legislature having jurisdiction over appropriations and financial affairs and the joint standing committee of the Legislature having juris- diction over health and institutional services.

The departments and division, as defined in sec-19 20 tion 1642, shall prepare a written report of social 21 service and related health and medical services information, including anticipated federal funding, an-22 ticipated current services budget figures, policy 23 24 matters, service priorities and their estimated costs and other program issues pertaining to operations. 25 26 Copies of the report shall be provided to the joint 27 standing committee of the Legislature having jurisdiction over health and institutional services 28 and 29 the joint standing committee of the Legislature hav-30 ing jurisdiction over appropriations and financial 31 affairs and shall be widely distributed to the public 32 and community social service agencies.

The report containing all recommendations for the upcoming biennium shall be presented to the Legislature concurrently with the timetable provided in section 1666 and its successors. An updated report shall be presented to the Legislature at the Second Regular Session.

STATEMENT OF FACT

2 The Social Services Planning and Expenditure Act is amended to remove provisions inconsistent with the 3 4 Revised Statutes, Title 5, section 1666 and its suc-5 cessors. This bill provides for a Maine Social Ser-6 vices Report which annually compiles program and bud-7 get information on the social services programs administered by the Department of Human Services, the 8 9 Department of Mental Health and Mental Retardation and the Division of Community Services. 10
