place the underlined word 'INTERNSHIP'

Further amend the bill in section 1, in that part  
designated "§321." in the first and 2nd lines (page  
1, lines 25 and 26 in L.D.) by striking out the un-  
derlined word "Apprenticeship" and inserting in its  
place the underlined word 'Internship'

Further amend the bill in section 1, in that part  
designated "§321." in the first paragraph, 2nd line  
(page 1, line 28 in L.D.) by striking out the under-  
lined word "Apprenticeship" and inserting in its  
place the underlined word 'Internship'

Further amend the bill in section 1, in that part  
designated "§322." in subsection 1, in the 4th line  
(page 2, line 4 in L.D.) by striking out the under-  
lined word "apprenticeship" and inserting in its
