11 Amend the amendment by inserting after the title
12 the following:

13 'Amend the bill in the title, in the 2nd line by
14 striking out the words "Loaders and"

15 Further amend the amendment in the first para-
16 graph after the title in the first line (page 1, line
17 10 in amendment) by striking out the word "Amend" and
18 inserting in its place the words 'Further amend'

19 Further amend the amendment in the 2nd paragraph
20 after the title, in the first line (page 1, line 13
21 in amendment) by striking out the figure "36" and in-
22 serting in its place the following: 'Sec. 1. 36'

23 Further amend the amendment in that part desig-
24 nated "§1765." in subsection 4, by inserting after
25 the following: "Aircraft;" the underlined word 'or'

26 Further amend the amendment in that part desig-
27 nated "§1765." by striking out all of subsection 5
28 and by renumbering subsection 6 to be subsection 5.

29 Further amend the amendment by inserting before
30 the fiscal note the following:

31 'Sec. 2. Effective date. This Act shall take
32 effect on July 1, 1986.'

33 Further amend the amendment in the fiscal note by
34 striking out all of the last 3 lines (page 2, lines 4
