No claim otherwise allowable may be granted to claimants of single member households with household income in excess of \$5,600 in calendar year 1980 and \$6,200 \$ \$6,500 in each succeeding year for which relief is requested; and no claim otherwise allowable may be granted to claimants of households of 2 or more members with income in excess of \$6,700 in calendar year 1980 and \$7,400 \$ \$8,000 in each succeeding year for which relief is requested.

11 Sec. 3. 36 MRSA §6110, as repealed and replaced by PL 1973, c. 771, §2, is amended to read:

§6110. Benefit limitation

No claim of less than \$5 or more than \$400 shall 15 \$800 may be granted.
